Keeping in view of the practical difficulties encountered while processing the applications through Mee-Seva last year, it has been decided to reduce the number of documents to be uploaded through "Mee-Seva".

The existing, valid licence holders of the Department, who have to apply for renewal of their licences before November 30th of 2015 have to submit their licences for renewal at the "Mee-Seva" centers along with the attachments enclosed in Annexure- A.

The list of documents that are to be submitted to the Inspectors/District Inspectors/Assistant Controllers during the process of physical inspection of the premises of the Licence Holders is enclosed in Annexure- B.

The Assistant Controllers are instructed furnish their remarks either for renewal or rejection specifically after duly verifying all the originals attached/nonattached documents thoroughly before forwarding the applications to Head Office. The Concerned Inspecting officers along with the Assistant Controller will be held responsible for any lapses noticed later on.

The Regional Deputy Controllers are instructed to monitor the overall processing of applications in their region and ensure that all the applications which were received for renewal shall be forwarded to Head office before 31-12-2015.
