## **Alteration of Dealer License**

## **Procedure for Alteration of Dealer License**

- 1. Apply online on the Single Desk Portal on AP industries department
- 2. Select legal metrology services under Apply for Approvals
- 3. Select Alteration of Dealer License from the List of Services under Legal Metrology Services listed and click on Apply
- 4. Fill the application form& upload the necessary documents
- 5. Pay the requisite fee
- 6. Submit the filled application online
- 7. Generate unique identification number
- 8. Computer allocates industrial establishments to be inspected by the Inspecting Officer and probable date of inspection
- 9. The Inspecting Officer sends SMS about the date of inspection, to the industry to be inspected
- 10. The Inspecting Officer inspects the industry on the designated date
- 11. The Inspecting Officer inspects the industry, as per the check list communicated
- 12. The Inspecting Officer prepares a Inspection Report in prescribed proforma
- 13. The Inspecting Officer generates an Inspection Report with unique Id no. (File No.)
- 14. The Inspecting Officer digitally signed Inspection Report
- 15. The Inspecting Officer uploads Inspection Report onto the website within 48 hours
- 16. The Inspecting Officer send SMS about availability of the Inspection Report and its identification number, on the website
- 17. The applicant downloads the Inspection Report from website.
- 18. The applicant can check the status of the application using the unique identification id.
- 19. After final approval, the applicant received SMS and can download the final digitally signed Alteration of Dealer certificate online.
