The Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India has envisaged a new concept for minimizing the Regulatory Compliance Burden for Entrepreneurs as a part of Ease of Doing Business Reforms(EoDB). In order to comply with the Reforms requirement, the Department has already switched over to Autorenewal process for all the Licenses of the Department, i.e., Manufacturing, Repairing and Dealing Licenses. However, for further easing of the Entrepreneurs in Licensing, it is decided to remove / alter certain Regulatory Compliances pertaining to Licenses Grant & Alterations, Registration as Manufacturer/Packer/Importer, with a view to decrease the filing Procedures/Cost etc. Hence, the Joint Controllers and Deputy Controllers are hereby informed the revised list of documents which are required to be uploaded by the applicants for Grant & Alterations of Licenses and for Registration as Manufacturer/Packer/Importer, as per the Annexure appended.

Further, It is herewith instructed to carry out Randomized inspections only, as and when required, strictly adhering the instructions issued by the Controller, L.M., Govt. of A.P., Vijayawada from time to time.
