**NOTIFICATON**

In exercise of the powers conferred by sub-section (1) of Section 53 of the Legal Metrology Act 2009 (Act 1 of 2010), the Governor of Andhra Pradesh in consultation with Central Government, hereby makes the following Andhra Pradesh Legal Metrology (Enforcement) Amendment Rules 2019, the draft of which was published in the Rules Supplement to Part - I Extraordinary of the Andhra Pradesh Gazette No.G-1409, dated the 25<sup>th</sup> March, 2019 as required by sub-section (4) thereof and duly considering the suggestions and objections received in this regard.

**THE ANDHRA PRADESH LEGAL METROLOGY (ENFORCEMENT) AMENDMENT  
RULES, 2019**

1. Short title, Extent and commencement –

- (1) These Rules may be called the Andhra Pradesh Legal Metrology (Enforcement) Amendment Rules, 2019.
- (2) They extend to the whole of Andhra Pradesh State.
- (3) They shall come into force on the date of notification by the Government

2. in the Andhra Pradesh Legal Metrology (Enforcement) Rules, 2011 (hereinafter referred to as the Principal Rules)-

- (i) for the sub-rule 4 of rule 11, the following shall be substituted, namely.-

“(4) Every licence issued to a manufacturer, repairer, or dealer shall be valid for a minimum period of one calendar year and may be renewed from one calendar year to three calendar years, by the Controller or such other Legal Metrology Officer as may be authorized by him in this behalf on payment of such fee for each calendar year, as specified in the Schedule IV.

Provided that an additional fee at full the rates specified in the Schedule IV shall be payable by the applicant if he is permitted by the Controller to make an application for the renewal of a licence within a period of three months from the date of expiry of the licence.

Provided that an additional fee at full the rates specified in the Schedule IV shall be payable by the applicant if the application for the renewal of a licence within a period of thirty days before the date of expiry of the licence.”

- (ii) for the Schedule IV under rule 11, the following shall be substituted, namely.-
