#### **GENERAL NOTIFICATIONS**

GRANT OF SKILL WORKER CERTIFICATE-REVISING OF EDUCATIONAL QUALI-FICATIONS AND PRESCRIBING TER-RITORIAL JURISDICTION Etc.

Procs. No. 14285/L/2015 For grant of licences, it requires prescribing terms and conditions by the Controller, Legal Metrology and these are binding on such licencees. In view of implementation of Legal Metrology Act 2009 from 1-4-2011, and also due to introduction of slew of new category of weights and measures due to technological changes, like in-motion weighing instruments, autometric gravimetric filling instrucments etc, a need has arisen for revision of list of category of weights and measures for issue of skill worker certificates and also for fixing of limitation of territorial jurisdiction to the skilled workers to protect the interest of consumers from the use of weights and measures in trade and commerce. A draft proposal was circulated to all Assistant Controllers and Regional Deputy Controllers of the State, for submission of the remarks.

Upon examination of the remarks of the Assistant Controllers and Regional Deputy Controllers, on the draft proposal, the Controller, Legal Metrology, Andhra Pradesh is pleased to issue the following amendments to the licence conditions prescribed from time to timr as well as to the process of issuance of skill worker certificate. The licence conditions are issued under Section 23(2) of the Legal Metrology Act, 2009 read with Rule 30 of the Andhra Pradesh Legal

Metrology (Enforcement) Rules, 2011 by the Controller, Legal Metrology, Andhra Pradesh, in the interest of public.

Accordingly, following notification is issued prescribing the conditions applicable for grant of skill worker certificate.

- 1. Skilled Worker: As defined in the Andhra Pradesh Legal Metrology (Enforcement) Rules 2011.
- 2. Who can apply: The person or applicant who is an ordinary resident of Andhra Pradesh and having requisite qualification and inquisitive to undertake repair weights, measures, weighing and measuring instruments can apply.
- 3. Qualifications for grant of skill certificate: As specified in the table.
- **4. Territorial Jursidiction :** AS specified in the table.
- 5. Grant of Skill Worker Certificate: The Controller may grant a Skill Worker Certificate, if all the requirements as may be specified from time to time are fulfilled.
- 6. Limitation: No person shall be granted skilled worker certificates in more than one category specified in the schedule. Provided that, if a person having skilled certificate in one field wants to have a certificate in new category, then he has to surrender the existing skilled worker certificate already granted to the Controller, Legal Metrology in order to get eligibility for applying new one.
- 7. Applicability: The propesed jurisdiction shall be applicable for fresh skill worker Cerrtificates to be granted from the date of its notification in Gazette.
- 8. Cancellation: The Skill worker certificate is liable for cancellation for contravention of any provisions of the Act and the Rules and Regulations or directions or instructions or orders issued by the Controller, Legal Metrology from time to time or any other law.
