The Government of India has brought the services rendered to the Industries by the State Government Departments under District Business Reform Action Plan 2020 (DBRAP), which is implemented by the Department of Promotion of Industries and Internal Trade (DPIIT).

The Certification on Verification of Weights & Measures and its re-verification (renewal) in respect of Industries' is one of the Services of the Department of Legal Metrology, Government of Andhra Pradesh mandated to be brought under District Business Reform Action Plan 2020 (DBRAP).

A new online software application is being introduced in the State through Single Desk Portal (SDP) of Industries Department Website for the service of online issue of Certificate of Verification of Weights & Measures and for its re-verification (renewal). Complete online system for the above service is being implemented and will go live in the State immediately. Therefore, all the Legal Metrology Officers are directed to adhere to the below mentioned guidelines for the above mentioned service from the date of go-live and stop manual receipt of the applications and issue of Certificates for Verification and re-verification (renewal).

- No physical / manual application shall be accepted.
- No physical copies of documents shall be requested by the Legal Metrology Officers and documents uploaded along with online application shall be accepted.
- A downloaded Verification Certificate shall be considered as valid Document for the purpose of compliance of the relevant provisions of Law.

The industries/business premises have been identified for implementing the reform action plan are enclosed in the Annexure.
