3.1 Powers and duties of officers and employees of the authority by designation as follows:

- iii. As per G.O.Ms.No.352 F&A (CS.III) Dept., dt.7-3-92 and G.O.Ms.No.579 I&C Dept., dt.11-11-1980, the appointing authority in respect of DCs/ACs./ILM without prejudice to various O.As/W.Ps in APAT/High Court.
- iv. As per FR & CCA Rules, the Controller, L.M., empowered to take disciplinary action on the Subordinates.
- v. As a Head of the Dept., he is empowered to take decisions on any matters pertaining to the implementation of the Act/Rules of the Dept.
- vi. As a Head of the Dept., he will initiate ACR's of JCs, and countersign on the ACR's of DCs, ACs & Inspectors, LM.

- vii. His Statutory powers are those as enunciated in the Legal Metrology Act 2009 and the rules made there under. He delegates powers to take independent decisions so as to make his subordinates to work effectively for realization of the objectives of the Dept.
